# Resource Development Team - Larry Brown

- Bank balance: \$48,000 (in round figures). Membership dues are pretty flat; currently we have 49 memberships representing 62 people (13 double households)
- Lease: Conversation with building manager, Mark. Renegotiated lease for August. Cost will be \$15/month more. Discussed our remaining in current space but considering move to larger space in building within the year; dependent on membership growth and need. Expectation that we could move to new space without penalty.
- Meet The Funders: Tuesday, September 12, 2017 from 8:00 AM to 12:15 PM; Muslim Educational Trust; 10330 SW Scholls Ferry Rd; Tigard, OR 97223.
  - Value: for networking with other nonprofits, making contact with funders who have commitment to nonprofits, and understanding possibilities for collaboration.

- Marketing recommending outreach to younger demographic. Kathe and Bonnie looking at website with this in mind.
- 101 review: Janet reported on 101 activity: 101 team has learned how to do it and confident in continuing. We have 9 people on project team and good number of presenters.
