Resource Development Team

- Team met December 10 with three new members bringing expertise and energy to team, one having grant writing experience
- Southminster grant for membership fee assistance now used up
- Discussed City of Beaverton grant proposal and possible reason for not receiving it. Larry will contact city staff for follow-up
- McMenamins proposal: No response yet
- End of year campaign: 29 donations received to date with \$3700 brought in. A
 follow-up is included in December Village Voice to let people know need for
 funds for programming.
 - The Governing Council will send thank you notes to people who have donated. Barbara B and Rae will develop a printed thank you note with Governing Council members signing cards and procedure for sending them.

Outreach and Publicity

- Business card: Ready for printing. Mission statement adapted for front of card along with Viva Village contact information. Back of card clear for card giver's contact information.
 - Text: Building and sustaining a strong community that connects, engages, and supports older adults
 - Governing Council authorized printing at \$45 for 1000 cards
- Brochure: Is ready for printing
- Subcommittee set up to review and update website
- BCOA (Beaverton Committee on Aging) collaboration. Two members participate
 in BCOA and will be reporting live to Governing Council on a regular basis. For
 first report they will be asked to give a presentation of the BCOA: purpose, who
 attends, how it functions. First report February 3rd if they are able to attend.
 Timing of follow up reports to be decided. Discussion suggested their
 attendance open to when there was something to report or discuss with
 Governing Council and on quarterly basis. Rae to contact them.

- External Partnerships:
 - Villages Northwest setting up program to encourage community partnerships. OPT will continue to participate.
 - Looking at Viva Village's agenda for outreach OPT has asked Barbara Bernstein's to attend a coming meeting.
 - Currently Senior Series planning team working with Beth Gilbert, Beaverton Library adult services librarian and Kera Magarill, DAVS, Multnomah County. Collaboration of programming including venue use being discussed.

Volunteers

- Volunteer Annual Survey: Review and follow-up continuing with contact being made to volunteers who did not respond.
 - As a result of suggestions from volunteers a Friday afternoon happy hour is taking place on the third Friday of month beginning January 17.
- Volunteer fall social: As a result of this event at least 11 volunteers expressed interest and became involved in operational teams

Membership

- Collaboration with Northeast Village: Team members met with NE Village
 membership leads to share information on NE's Village Partner Program and
 Viva Village's Neighborhood Connection Program. Purpose of exchange was to
 look at ways of supporting members at time of special need or for whom more
 personal involvement would help them get more out of Village membership and
 in remaining independent.
 - A committee of Membership team and Neighborhood Connection teams will look at possible adaptions to our current procedures
 - Follow-up with NE to take place next quarter
- 2020 Annual Member Meeting being scheduled for Saturday, April 25th, 18th, or 4th dependent on space at Southminster Presbyterian Church. Janet to see what is possible.
- Carol sending out notice for annual subsequent renewal phone calls and 360 interview needing to be completed.

Events

 Village Forums: The forums continue to be going well with attendance increasing and those attending appreciating the speakers and discussion. For the most part attendees have all been Village people even though forum open to the public. Discussion took place assessing whether the goal of forum to reach out to public being met. There was consensus that even though public not responding as hoped, the forum is an educational experience of value to Viva Village community. After discussion there was consensus that venue needed to be stable.
 Forum will remain at Methodist Church for next few months with search for venue with more space being made.

Leadership

- Governing Council Transition: With terms of three Governing Council members expiring in April 2020 discussion took place as to best way to provide continuity for Viva Village.
- Decisions:
 - The nominating committee will contact individuals and draw up list of candidates for Governing Council election
 - A Strategic Planning Meeting is scheduled on February 10 from 10:00 -4:00. Attendees will include people who will most likely be candidates for election to Governing Council
 - One agenda topic will be discussion of best means of establishing continuity and maintaining institutional memory for Viva Village
