 - Review of Seed of Sustainability campaign Viva Village will support this campaign in 2020 and raise awareness of our members can take advantage of the various plans available to them.
 - McMenamins Cedar Hills turned Viva down again for 2020, we may try McMenamins Murray and Allen in August.

- Fred Meyer giving program update Mid month update to all volunteers and members explaining how more people can take advantage of this program.
